The Scope of the Work for the both Hardware and Software as detailed below:

1. Supply and installation Traffic Signaling with Pole mounting.
2. The complete Red Light Violation Detection (RLVD) system with Camera integration.
3. Speed Detection.
4. No parking zone vehicle detection.
5. Server with control room setup with LED screen in BeMC office and online feed access to Two monitoring stations.
