The Commissioner, Berhampur Municipal Corporation invites sealed Tenders from any Individuals/ Firms for "Deweeding and Cleaning of Trash of Ponds under BeMC" for Berhampur Municipal Corporation.

The Start and end date of sale of Tender from 08/09/18 to 22/09/18. Tenders should reach the undersigned on or before 24/09/18 by 5.00 PM through Regd. Post/Speed Post and will be opened on 25/09/18 at 11.30 AM in the office chamber of the undersigned in presence of the tenderer or their authorised agents who intend to attend. The rate to be quoted shall be inclusive of all charges and taxes. No extra cost on any account whatsoever will be admissible. Conditional tenders will be rejected immediately. The rate should be written clearly and legibly without any error or overwriting and both in figures and in words. In case of difference or rates or any ambiguity over rates, then the rates written in words will be taken into consideration.

Scope of the Work and Mandatory Guideline:

- Each Bidder should furnish E.M.D. of Rs. 1,000/- (Rupees One thousand) per pond in shape of Demand Draft in favour of Commissioner, Berhampur Municipal Corporation. (Example: If one bidder is quoting rate for 5 ponds then he/she has to deposit Rs.5000/- in shape of DD as EMD)
- The scope of the work includes completely deweeding the pond and cleaning the Trash.
- The bidder should complete the work within 10 days of getting the work order, otherwise the EMD will be forfeited.
- The bidder can apply any number of ponds according to their convenient.

The sealed Tender should be superscribed on the cover as "Deweeding and cleaning of Ponds under BeMC". Further clarifications can be obtained from this office. The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
