The Commissioner, Berhampur Municipal Corporation invites sealed quotations from Authorised agencies/ firms/ manufacturers/ dealers/ suppliers for "Annual Maintenance of Vehicle Tracking System" for Berhampur Municipal Corporation.

Berhampur Municipal Corporation (BeMC) has installed 83 nos of Vehicle Tracking system of Atlanta OEM in different vehicles of BeMC. Now this office intends for Annual Maintenance for those VTS (including SIM cost and maintenance cost).

Each quotationer should furnish the following documents including EMD:

1. Authorisation from Principal Manufacturer/ OEM specific to this quotation.
2. The bidder should executed minimum 3 works in any organisation in similar fields. (Proof of the same to be provided).
3. Bid cost of Rs. 4480/- (including GST) in shape of DD in favour of Commissioner, Berhampur Municipal Corporation payable at Berhampur.
4. EMD of Rs. 5000/- in shape of DD in favour of Commissioner, Berhampur Municipal Corporation payable at Berhampur.
5. Firm Registration
6. GST Regn.
7. PAN Card

Scope of the Work of the Bidder:

1. The bidder should bear the SIM Data cost at their own.
2. The bidder should replace/repair the VTS devices if found faulty during the contract period.
3. Physical damage/ theft of the device will be borne by the BeMC.
4. The bidder should give 24/7 services throughout the year and the defunct devices should be repaired within 24 hours.
5. The payment for the services will be made on monthly basis.
6. Within the contract period, if any new procurement will be made, then Purchase order will be given at approved price of BeMC.
7. Any deviation to the above found by the undersigned, may cancel the tender and EMD will be forfeited and will be debarred for putting any tender to the BeMC.

Quotations should reach the undersigned on or before 26/03/19 by 5.00 PM and will be opened on 27/03/19 at 11.30 AM in the office chamber of the undersigned in presence of the quotationer or their authorised agents who intend to attend. The rate to be quoted shall be inclusive of Installation, handling and transportation / delivery charges (exclusive of GST)). No extra cost on any account whatsoever will be admissible. Conditional quotations will be rejected immediately. The rate should be written clearly and legibly without any error or overwriting and both in figures and in words. IN case of difference or rates or any ambiguity over rates, then the rates written in words will be taken into consideration.
