3. The Bid document shall contain copy of (i) Registration Certificate, (ii) PAN, (iii) GST Certificate, (iv) Cost of Bid Documents in Rs.7080/-, (v) Undertaking for No Relation certificate.
4. Bill Of Quantity with rate.
5. Bidder must have own ART Agency / Statue or Sculpture Manufacturing unit/ Registered manufacturing firm and experience in same field of minimum 03 years or have done same work in any of Govt. /Private Organization.
6. The Bid documents will reach the office of Brahmapur Municipal corporation office through speed post/Courier by Beyond the time period the quotation will not be accepted.
7. The delay of work for each day will attract penalty as per OPWD coded and for non-execution of work will attract forfeit all deposits during tender and in tender process and will not allow in future for any participation in BeMC.
8. The Terms of condition of Payment:
 - i. 60 % Payment of the agreement value will be made after completion of work in all respect.
 - ii. Next 15% Payment of the agreement value will be made after completion of one Year.

The top surface of size 4'8"x4'8"and four sides of the base will be covered with best quality granite and tiles respectively. B. The 5 no statue will be made on FRP 400mm double layer having inside 25mm square pipe skeleton frame covered with frame hardeners cobalt Rexene. The statue base of average size 2'0"x2'0", chest size average will be 2'0"x2'0"and top will be average 1'0"x1'0". The FRP cover will be painted by urethane paint double coat over a coat of urethane primer single coat. C. The 5 no statue top will be covered with a designer style made with 0'6" single GI pipe and frame on 35mm x 35mm square pipe, coated with frame hardeners cobalt Rexene, covered on FRP 400mm double layer and painted with urethane paint double coat over a coat of urethane primer single coat. D. Providing supplying and installation of ladder of top-quality gaze & materials of 6mt length and 0.60 mt width for 8 feet statues of 5 nos statue and 9mt width with 0.60 mt width for 12 feet statue of 2 no including one coat priming and two coat painting etc. complete with garlandong to the statue .
