1. INVITATION OF BIDS:

The Commissioner, Brahmapur Municipal Corporation invites Item Rate Tenders in conformity with the terms and conditions of the Detailed Short Tender Call Notice (DTCN)/ Bid Documents for the each Works mentioned in ANNEXURE – 'A' attached to this NIB from the intending bidders.

2. ELIGIBILITY CRITERIA OF THE BIDDERS:

(a) Each intending bidder should have been validly registered as a Contractor in MV/HT and electrical contractor and Supplier, Manufacturers or Authorised Dealers and GST registration certificate, copy of the PAN card, GST Clearance Certificate as applicable.

3. INSTRUCTIONS TO THE BIDDERS:

Apart from above, each intending bidder should possess/fulfil other eligibility criteria as mentioned in the DTCN/Bid Documents. DTCN for work consisting of Schedule of Quantities, a set of Terms and Conditions and other necessary information can be seen in this office during office hours every day except Sundays and Public Holidays till the last date and time of sale/receipt of the tender papers. Interested bidders may obtain further information from this office physically.

4. The sale of the Bid Documents shall start from Dt. 30/07/26 and will be closed on Dt. 04/08/26 at 15.00 P.M. Bid documents can be purchased from this office on payment of the cost with GST (18%) as mentioned against each work in the Annexure. The cost of tender documents and GST are non-refundable. Payment for the tender documents will be received in shape of Account Payee D.D/Pay Order drawn on any Nationalized/Scheduled Bank and payable at Brahmapur in favour of Commissioner, Brahmapur Municipal Corporation. DTCN/Bidding Documents, on written request, can also be sent from this office by Registered/Speed Post. The bidder should submit required document with E.M.D as annexed to the office of the undersigned before due date. The undersigned will not be held responsible for the postal delay, if any, in the delivery of the documents or non-receipt of the same.

5. Sealed bids will be received by Registered Post /Speed Post only by Dt. 07/08/26 up to 17.00 P.M. the bidders should super scribe on the top of the sealed cover "Corporation Electrical Work Name". The undersigned will not be held responsible for non-receipt/late receipt/any damage or distortion caused to the tender documents during transit.

6. The bids will be opened on Dt. 10/08/26 at 11.30 A.M. in the office of the undersigned in presence of the respective bidders or their authorized representatives who intend to attend. If the office happens to be closed on the last date of receipt and opening of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. The rates to be quoted shall be inclusive of all taxes, royalties, handling and delivery charges. No extra rate on any account whatsoever will be admissible. Conditional tenders will be rejected immediately. The rates should be written clearly and legibly without any error or overwriting and both in figures and words. In case of difference of rates written in words and figures or due to other reasons, the rate quoted in words will be taken into consideration. Non-quoting of rate(s) either in words or in figures or in both for any item(s) will be treated as incomplete tender. The schedule of quantities and other forms attached to DTCN Section- VIII should be signed at appropriate places by the tenderer only without which it will be treated as an incomplete tender. All incomplete tenders will

be rejected immediately. The tender must be accompanied with a bid documentation duly signed by the contractors, other documents and forms for each work as mentioned in the DTCN.

7. Name of the purchaser at the time of procurement of DTCN should not be disclosed. No money receipt shall be given indicating the name of the purchaser at the time of purchase of DTCN.

8. Only ink/dot pen signed copy of DTCN issued by the office shall be entertained.

9. Other details can be seen in the bidding documents. The authority reserves the right to reject any or all the tenders or approve any tender without assigning any reason thereof subject to the limitations fixed by Central Vigilance Commission.
